- 1. The date of effect of pay revision will be 01/07/2014 and date of effect of allowances at the revised rate will be 01/02/2016.
- 2. The following rules specified in G.O(P)No.07/2016/Fin dated 20/01/2016 should be scrupulously followed while implementing pay revision.

- 3. There will be no option facility.
- 4. No benefits other than those mentioned above will be granted without specific prior orders from the Government. Any further orders issued in continuation of G.O(P)No.07/2016/Fin dated 20/01/2016 shall be applicable to employees of KSREC only with the prior concurrence of Government.
- 5. In case of any doubt regarding fixation of pay, anomalies etc prior consent of Finance Department should be obtained before arriving at a decision.
- 6. Under no circumstances stepping up of pay will be allowed without prior approval of the Government.

7. Contribution towards EPF will be calculated on the basis of Government of India notifications.

8. No appointments (permanent/deputation/temporary/daily waged/ provisional)shall be made in the posts created without approval of Government and no new post will be

created without prior Government Orders.

9. No ratio based promotions, up gradation or re designation shall be done without

prior approval of Government.

10. Entire expenditure on the revision of pay and allowances will be met from the

internal resources of KSREC. Government will not provide any financial assistance on

account of this.

11. Executive council of KSREC will decide on the payment of arrear salary based on

the financial position of KSREC subject to para 46 of General Pay Revision Order

2014.

12. Under no circumstances plan grants, if any, released by Government will be

diverted for meeting establishment expenditure including salary expenditure. Item

wise expenditure incurred out of Government grants will be specifically noted in the

annual accounts.

13. Director, KSREC will be held personally liable for deviations from the above rules

while implementing the revision of scale of pay.
